Pledge of Allegiance recited.

Council President Jerome Ogden called Blossburg Borough Council regular meeting to order at 6:30 P.M. in the Council Room of the Borough Building, 245 Main Street, Blossburg, PA.

Brendyn Stager and Dick Stager attended the meeting to express their interest in purchasing the former Borough Hall. Brendyn Stager would like to change the former Borough Hall into \pm nine (9) apartments and is willing to work with newly proposed historical society, so they can use part of the building. Shane Nickerson has been working with Brendyn as to the repairs that need to be done on the building. A new roof is needed as soon as possible. Mr. Nickerson would like to get this job started before it gets too cold. Council asked Brendyn to write a letter expressing his purpose for the building and to provide a letter of intent from his financing bank. Borough Council Meeting continued from October 10, 2005 – Reconvened October 17, 2005 at 6:30 P.M. in the Council Room of the Borough Building, 245 Main Street, Blossburg, PA.

<u>Attendance</u>: President Jerome Ogden; Vice-President Tonya McNamara; Councilmembers Raymond Kaminski, (absent, James Holleman), Cheryl Bubacz, (absent, Timothy Roupp), Thomas Bogaczyk; Mayor John Backman; (absent, Borough Solicitor Patrick Barrett); Borough Manager George D. Lloyd; (absent, Borough Secretary Mary Signor).

Guests: Sandra Olson; Brendyn Stager and Dick Stager.

Former Borough Hall:

Sandra Olson read a proposal to Borough Council on the newly formed Coal and Iron Historical Society of Blossburg, which was incorporated as a private Nonprofit Corporation with the Pennsylvania Department of State on September 26, 2005. The organization will operate under the direction of twelve (12) person volunteer board directors. The organization is in the process of applying for 501 (c) (3) status with the IRS, which would allow for tax-free donations and also application for grants for renovation and operation of a museum.

The purpose of the Society was incorporated to collect and preserve the history of coal mining and related industries in the greater Blossburg area. The intent of the organization is to collect and preserve items from the coal-mining era and educate future generations about the history of our area. Special emphasis will be placed on the ethnic history of our area.

The next step is to get an organizational meeting scheduled to elect officers and board members.

The historical society has plans for developing and operating a museum in which to display artifacts from the coal-mining era and also to provide educational opportunities to interested parties especially students. The organization has as a goal to procure the old Blossburg Borough Building for a museum operated by the historical society. The organization would like the borough to gift/convey the building to the historical society for \$1.00. Plans are to renovate the building while maintaining the historical character of the building and eventually to try to obtain historic register status.

Lonny Frost, Blossburg V.I.B.E. (Visions in Business and Entertainment) representative, could not attend tonight's meeting, but sent in a letter expressing his views on the former Borough Hall. Lonny Frost asked Sandra Olson to read the letter on his behalf. Mr. Frost feels the building would benefit more people if it was used as a tourist attraction. The entire town of Blossburg would benefit from the income coming in from tourists.

Brendyn Stager presented his letter of intent, a letter of financial backing from First Citizens National Bank, apartment floor plans and a proposal from Nickerson Construction for the repair and installation of a new roof for the former Borough Hall.

All information from tonight's meeting will be forwarded to Borough Solicitor Patrick Barrett for his review and legal advise.

Equipment Auction:

A resolution is needed to borrow money for equipment auction bid on a 1995-1996 Tandem Dump 10-wheel truck to convert into a garbage truck. Limit to bid is \$40,000.00.

Resolution to Authorize a \$40,000.00 Limit to Bid on a 1995-1996 Tandem Dump 10-Wheel Truck: Resolution adopted on motion of Raymond Kaminski; second, Thomas Bogaczyk. All in favor.

Budget:

2006 Blossburg Borough budget balanced with no tax increase. Motion to advertise 2006 Budget Ordinance was made by Thomas Bogaczyk; second, Raymond Kaminski. All in favor.

2006 Budget to be adopted at the December 12, 2005 meeting.

At the April 11, 2005 Council Meeting a motion was made to raise Occupation Privilege Tax from \$10.00 per person to \$20.00 per person for 2006. The ordinance needs to be advertised. Borough Solicitor to have ready for next Council Meeting.

Computer / Video Camera:

Mayor Backman reported that Tioga County would be installing a computer / video camera in his office for the District Justice to use on weekends and in emergencies. Council in agreement that the installation would help the District Justice and a police officer from traveling to Mansfield, Wellsboro or Elkland to process charges.
