(G) Borough Manager:

He served on Elkland Borough Council and also served as Council President. He was the current Borough Manager. Zoning Hearing Board:

A meeting was held on September 11, 2008. Lewis Brill, owner of a single family dwelling, 302 North Williamson Road applied for a variance. The proposed addition would be too close to an existing right of way. The ZHB members passed the request.

Councilmember Jill Nickerson presented her findings on the Borough's help with in-kind services to the Recreation Board in regards to pool testing. Mrs. Nickerson's showed a loss on the Recreation Board income/expense report. Borough Manager George Lloyd reported the Recreation Board pays the mowing of Island Park. He feels since the Park is Borough property the Borough should pay for this service. The mowing wages totaled \$4,700.00 on the expense report. Pool Testing, Misc. totaled \$2,791.79. Councilmember Thomas Bogaczyk made a motion to have the Island Park mowing wages paid from the Borough General Fund and Recreation Board continue paying the Pool Testing, Misc; second, Jeffrey Everett. All in favor.

Recreation Board members and volunteers are meeting tonight at 7:00 P.M. in the North Penn High School Library to stuff envelops for the 2008 North Penn Area United Fund campaign fund drive.
