Pledge of Allegiance recited.

Council President Jerome Ogden called the Blossburg Borough Council regular meeting to order at 6:30 P.M. in the Council Room of the Borough Building, 245 Main Street, Blossburg, PA.

Reports:

- (A) NPHS Student: School is out for summer break.
- **(B)** KCC: David Thompson, Sr. reported the organization's regular checking account balance is \$661.84. All bills are paid.

(C) <u>Committee Business Development</u>:

Blossburg V.I.B.E. (Visions in Business and Entertainment) V.I.B.E. meetings are held on third Wednesday of the month in the community room of the Blossburg Memorial Library at 6:00 P.M.

V.I.B.E. Minutes were printed off the Internet and distributed to Councilmembers.

Councilmember Jill Nickerson reported there are 100 reservations, to date, for "Music Meets Memories" event, which is scheduled for August 1, 2008.

Skate Park: DCNR Grant Application was mailed. No reply yet.

(D) Mayor: On June 24, 2008, Mayor Backman took the wheels from the World War I cannon to Vicksburg, PA for repair.

Tony Shattuck, a local serviceman and former North Penn High School student was wounded on June 26, 2008 in the country of Afghanistan. Mayor Backman proclaimed today, Monday, July 14, 2008, for the citizens of Blossburg to wish Chief Petty Officer Tony Shattuck a full and speedy recovery.

Reports:

Councilmembers commended the Police for the prompt work in solving the vandalism painting that was done on different areas of Island Park.

Council discussed the use of tasers. Corporal McCurdy to check on the cost of taser equipment including training and report back to Council at next month's meeting.

(G) Borough Manager:

Borough Manager Report accepted. Motion of James Bogaczyk; second, Jeffrey Everett. All in favor.

The Borough Manager reported on the following items:

Tar and chipping of borough streets was completed on July 11, 2008.

The new water line from Blossburg to Morris Run was started on June 24, 2008.

On Wednesday, June 18, 2008, Blossburg Borough got the bid for the 1997 International Single Axle truck from online Asset Auctions – PennDOT Equipment – in the amount of \$12,500.00.

The repair cost for the World War I cannon on Island Park is approximately \$2,000.00 for wheels repair, \$5,000.00 for footer/mount and \$100.00 for miscellaneous expenses. Council would like to shop around for better prices.

Seismic testing started North of Bath and will go to Interstate 80 ± 140 miles. The company should travel 5 miles / day.

(H) Planning Commission:

No applications were submitted. No meeting.

Nathan McNamara agreed to serve as a member on the Planning Commission.

Zoning Hearing Board: No meeting.

Borough Manager is waiting on replies from nominated replacement names for Zoning Board member Jeffrey Manikowski.

(I) Recreation: Councilmember James Bogaczyk reported on items discussed at Recreation Board meeting:

More mushroom soil to be brought in for the football field this fall.

Reports: Swimming lessons have started. Fuel prices seem to be affecting the daily

attendance at pool.

(J) <u>Fire</u>: No meeting.

(K) <u>Television</u>: Board meetings are second Tuesday of month.

(L) <u>Library</u>: The next Quarterly meeting is in July.

Computer classes are being offered at the library.

The annual Library Garden Party fundraiser will be held on July 27, 2008 at the

Hamilton Club in Morris Run.

(M) <u>Street Committee</u>: Discussed earlier.

(N) <u>Budget</u>: Act 8 of 2008 (House Bill 1133) has passed and provides Borough officials with new

Fire and EMS budgeting tools.

"The Act directs borough officials to meet with fire and EMS personnel to evaluate service needs. These meetings would take place at least annually, in conjunction with the budget process. Fire and EMS organizations are required to provide borough officials with an itemized accounting of expenditures that were paid for out of borough appropriations from the previous year. This itemized accounting <u>must</u> be presented <u>before any additional funding</u> can be considered by the borough. This will prove to be an invaluable tool for borough officials as they deliberate budgetary requirements for the next budget cycle."

Council suggested a letter should be sent to the Blossburg Fire Company explaining the

Act 8 of 2008.

(O) Blossburg Municipal Authority (BMA): Nothing to report.

OLD BUSINESS:

1. Minor Sub-Division/Cul-D-Sac:

The Borough Manager gave information to the Borough Solicitor.

2. Cell Tower Ordinance: Borough Solicitor sent to another lawyer for his review.

3. Borough Building Repairs / Estimates:

Borough Manager George Lloyd to get separate prices for concrete work and window replacements. The Borough Building would be eligible under the Main Street Façade Program for the building sides that face Main and Carpenter Streets.

4. Island Park Oil & Gas Lease:

Borough Solicitor Patrick Barrett researched East Resources proposed lease. Mr. Barrett suggested subsurface lease only, no drilling, no gas storage, and no access through Island Park. Councilmember James Bogaczyk made a motion to allow the Borough Solicitor to put together a plan and submit for bid; second, Thomas Bogaczyk. All in favor.
