PUBLIC HEARING August 17, 2009

As advertised a Public Hearing was held on August 17, 2009 at 6:00 P.M. in the Blossburg Fire & Ambulance Building located at 324 Main Street, Blossburg, PA. The purpose of the Public Hearing is for a request for reclassification of zoning submitted by the Williamson Land Company. The Williamson Land Company is requesting the reclassification of Tax Parcel 02-07 A00-015A, consisting of 10.13 acres located on Bloss Mountain Road zoned as Commercial to Heavy Industrial.

Williamson Land Company representatives, Richard "Rusty" Taylor and David Hedrick, attended the meeting in response to the rezoning request for the property located next to the Kwik Fill on Old Route 15 that borders Ward Manufacturing and Taber Street. They were seeking the property to be rezoned from commercial to heavy industrial for the purpose of erecting a frack water recycling center, worth over \$5 million. The plant would remove chemicals, mostly salt, from the water which flows back to the surface after a Marcellus Shale natural gas well is hydrofractured. This plant would employ approximately 10 employees, with 24 / 7 operations, and include 250 trucks coming and going each day.

Local residents expressed concerns on what type of chemicals are found / used in the recycled wastewater, as well as, a chemical spill at the plant or a truck spill due to an accident in route to or from the plant. Another concern is the increase of traffic coming off Route 15 and including the increase of traffic in the borough. Some residents that live in close proximity were concerned about noise and light issues. Councilmember James Bogaczyk discussed the risks of traffic flow on the off ramps at the proposed plant location.

The rezoning of the land is only the first step in the process before construction of the plant can begin.

Those attending were reminded by Council President Jerome Ogden, "A change in land use; that is the only thing we can address."

The Public Hearing was closed, leaving many unanswered questions for local residents.
