#### OLD BUSINESS:

#### 1. Southern Tioga School District (STSD) Plans for New North Penn High School:

Four candidates, for the Southern Tioga School Board, were interviewed to fill an open seat created by the resignation of Bob McConnell.

#### 2. Borough Code of Ordinances – Update:

Recently adopted ordinances were sent to Keystate Publishers, so they can incorporate into the New Borough Code from Pennsylvania. Borough is expecting new updated book soon.

Borough Solicitor is to contact Keystate Publishers, again, on status.

#### 3. Condemned Properties Update:

(1) 219 South Williamson Road – Nothing. Property owner does have a demolition permit.
(2) 127 Schuylkill Street – A contractor wants to purchase and fix up property, but Federal Liens are a problem. Mr. Lloyd is to contact Attorney Larry Mansfield for consultation on property.

#### 5. <u>New Electrical Service Behind the Downtown Monument:</u>

#### NEW BUSINESS:

#### 1. Ordinance No. 435: 2013 Tax Ordinance:

Motion that the proposed 2013 Tax Ordinance be adopted as advertised: Borough 5.807 mills / Fire 0.568 mills / Library 0.250 mills, totaling 6.625 mills was made by Jerome Ogden; second, Paul Hosszu. All in favor.

#### 2. Mansfield Area Water Task Force:

The Blossburg Borough received a letter from the Mansfield Area Water Task Force asking financial assistance for a professional assessment of the water supply, sewage treatment and infrastructure needs in the I-99 corridor. Mansfield Area Water Task Force's request is being made to potential partners within the I-99 designated area. Rettew Group has submitted an assessment proposal at the cost of approximately \$30,000.00. Mansfield Area Water Task Force is suggesting a commitment of \$5,000.00 from each municipality <u>AND</u> its associated municipal authority to pay for this project. A January 16, 2013 response is requested. Rettew Group is to begin work in February and the completion date is late June or early July.

Act 13 monies are permitted to be used for planning purposes.

Councilmembers would like to have a meeting with the Mansfield Area Water Task Force before committing to the \$5,000.00 request. David Flesch is to be contacted to ask if January 14, 2013 at 4:30 P.M. would be a good time for all to meet.

## Mansfield Area Water Task Force:

David Flesch, Mansfield Area Water Task Force Representative and Ed Trask were attending the meeting to answer concerns and questions Councilmembers have on their intentions.

I-99 economic development is at a standstill, because of the water supply and sewage treatment.

Rettew Group, Planning and Consulting Services, has proposed a Tioga County – Regional Needs Assessment for the region's economic development future. Rettew Group assessment cost is approximately \$30,000.00.

The Blossburg Borough was contacted by the Mansfield Area Water Task Force asking for financial assistance in paying for the professional assessment. Mansfield Area Water Task Force is suggesting a commitment of \$5,000.00 from each municipality <u>AND</u> its associated municipal authority to pay for this project.

After discussing the needs for the assessment funds, Stephen Wagner made a motion to commit \$5,000.00, from Act 13 Money Market, to Mansfield Area Water Task Force towards the Rettew Group Tioga County – Regional Needs Assessment; second, Paul Hosszu. All in favor.
