# BLOSSBURG BOROUGH COUNCIL MEETING September 13, 2017

Council President Jolene Hall called the Blossburg Borough Council regular meeting to order at 6:30 P.M. in the Council Room of the Borough Building, 245 Main Street, Blossburg, PA.

No emergency person responded. At 5:22 A.M. Wellsboro ambulance crew arrived. Mr. Belawski stated something needs to be done for quicker emergency responses. At the present time, Blossburg emergency personal is notified. If Blossburg is unavailable Mansfield personal are contacted. If Mansfield is unavailable then Wellsboro is called. All county ambulance and fire departments are volunteers. These people respond if they are able to. Countywide EMS personal are trying to make the system better. Borough Solicitor Patrick Barrett suggested the situation to be investigated through the Blossburg Ambulance Association. There are many factors as to why the emergency crew may not have

responded.

This limitation shall apply regardless of the cause of action or legal theory pled or asserted." Mr. Lloyd is to contact Mr. Bray on the \$5,000.00 limit.
