# BLOSSBURG BOROUGH COUNCIL MEETING October 11, 2017

Council President Jolene Hall called the Blossburg Borough Council regular meeting to order at 6:30 P.M. in the Council Room of the Borough Building, 245 Main Street, Blossburg, PA.

#### Reports:

(A) <u>Junior Council Person</u>: Junior Council Person Eion Hicks-Lee reported kids would like tree-

houses added to Island Park playground area. Treehouses were discussed in the planning stages of the new playground, but insurance

coverage for accidents is an issue.

## (F) **Borough Manager**:

The owners of the Holiday Market at Riverside Plaza are requesting reserved parking in front of their business for internet shopping customers. The reserved parking space would be for 10 minutes and used for picking up internet purchases from the store. Motion was made by Jill Nickerson to approve the "to go" pickup parking space in front of the Holiday Market; second, Tonya McNamara. All in favor.

#### (H) Recreation:

The Minutes from the August 31, 2017 were received.

Tonya McNamara discussed a program at Mansfield University called "Public Relations Workshop", which she feels could be used to promote Island Park. The project would be handled by MU juniors and seniors during the spring semester, to develop a public relations campaign and implement a special event. A park representative (Tonya McNamara would volunteer) would meet with the class for initial discussion about the parks needs and challenges. Councilmembers would like to know if there is a cost for the project, if the Borough is chosen for the project. Mrs. McNamara will be discussing this program at the next Recreation Board Meeting.

#### **Reports**:

Young Lungs at Play: As discussed at the September 13, 2017 Council Meeting, complaints were received of smoking on Island Park by tennis courts, basketball court, and baseball fields. Borough does not have a No Smoking Resolution / Ordinance covering Island Park. Borough Solicitor Patrick Barrett will write a "No Smoking Resolution" for Island Park. Jill Nickerson is to request Young Lungs at Play signs sponsored by Pennsylvania Department of Health, Bureau of Health Promotion and Risk Reduction Division of Tobacco Prevention and Control Pennsylvania. Designated smoking areas are to be selected (i.e. by Borough Garage, etc.)

Playground: Curbing is in and to be outlined with "Sell of Bricks".

<u>Tennis Courts</u>: Tennis courts are done. A crack was discovered in the tennis court coating.

Millers Flooring Company to repair crack on October 12, 2017.

The Borough Manager is to get cost estimate for coating the basketball court.

<u>Trees</u>: Planting of trees around the big pavilion at park is on hold until new playground is

completed.

Island Park River Walk: Nothing to report.

(I) <u>Fire</u>: The Minutes from the August 25, 2017 were received. No Financial Report was made available. Councilmember Jerome Ogden requested a YTD Profit / Loss Report for the Departments.

The 2017 Halloween Parade and judging of costumes will be sponsored by the Blossburg Fire and Ambulance Departments.

(J) Library: October 17, 2017 is the next Library meeting.

Blossburg Memorial Library was selected to participate in a statewide Office of Commonwealth Libraries' Turning Outward pilot program. "Turning Outward means looking at others as resources and finding new ways to look at things." "It means opening eyes to a whole new way of thinking and collaborating, and really creating understanding."
