Renee Carey: The GP1 Application for the riverbank stabilization and fish habitat structures is completed and ready to be filed. The funding is in place. Before the Conservancy can transfer the property, they must resolve the additional acreage that was noted during the survey. They are close to having the necessary rights-of-way in place and are in negotiations with a few additional landowners. If you know of anyone waiting for any answers, please let Renee know.

They are working with a sign design company for new welcome signs. Tonya is working with PennDot. They hope to have final designs in the near future.

Recreation:

The Rec Board met but did not have a quorum. A discussion with held regarding the status of the swimming pool in Wellsboro and if/when it will open for this season.

We have an ongoing issue with an individual who is sleeping at the Park. Need to check the signs at the Park regarding closed hours, etc. Solicitor said that the Mayor can make an emergency proclamation to announce the hours the Park is open and closed.

Penelec is waiting for us to have our panel in place before they will start the electric installation at the little league fields. Borough Manager suggested that we put the panel in a building similar to the new restroom building with ½ for the electric panel and the other ½ for a concession stand. This will be discussed at the next meeting.

A discussion commenced regarding the Wi-Fi on the Park and what is needed for the Borough, pool and community. Borough Secretary mentioned that our computer consultant, CSR, would like to meet with Josh Jones and Joe Bubacz and possibly a contractor that CSR works with to discuss these needs and any additional security services needed.

A status report from the Library was received. They are doing very well.

Street Committee:

Borough Manager provided a map showing the streets proposed for tar and chipping. The total proposed would be approximately \$64,725. This amount was budgeted through Liquid Fuel funds.
